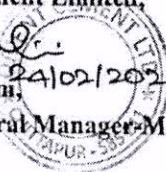



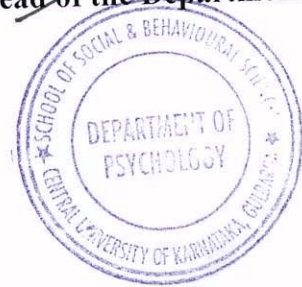

The process is as follows:

A) Once the agreement is signed, an invoice is to be sent to FVTRS for a 50% advance of the total budget mentioned on the Research Assistance Agreement (RAA) in Annexure II. If GST is applicable, the GST amount is to be added. The invoice should be a tax invoice, signed by the PI of the consultation project.

B) Within 30 days of the end of the term mentioned in the RAA, the Institution should submit a utilization statement as per the agreed format, confirming actual expenses incurred during the project, and this should be signed by the PI and the Head of the Institution's administration.

C) Individual bills must be maintained by the Institution and should be submitted only if requested.

D) At the end of the project, the Institution and the Researcher should submit a joint declaration (as per agreed format) that the amounts disbursed by the FVTRS have been utilized only for the purposes as specified in Annexure I of the RAA.

E) Upon completion of the Project, the Institution shall promptly return any unutilized portion of the annual budget to the University, along with the GST paid on the unutilized amount, if applicable.


