## MEMORANDUM OF UNDERSTANDING (MOU) FOR ACADEMIC AND CLINICAL COOPERATION

This Memorandum of Understanding is entered into on 22<sup>nd</sup> Oct. 2018 between the CENTRAL UNIVERSITY OF KARNATAKA (CUK), KALABURAGI represented by the Registrar hereafter to be called the 'FIRST PARTY' and the Dharwad Institute of Mental Health and Neurosciences (DIMHANS), Dharwad represented by the Director, hereafter to be called the "SECOND PARTY".

**Central University of Karnataka (CUK), Kalaburagi** is one of the rapidly growing new Central Universities established under an Act of Parliament 2009 by Government of India. The University is fully funded by the University Grants Commission (UGC). The Hon'ble President of India is the Visitor of the University. The University has 654 acres campus, situated near Kadaganchi village in the district of Kalaburagi, Karnataka state. The main objective of the University is to integrate the components of Teaching, Research, Innovation, Training and Skill Development with an aspiration to excel in integrated programs, post graduate, M.Phil. and doctoral programs.

**Department of Social Work** was established in the year 2012. The Department with a blend of interdisciplinary knowledge systems, aims to generate a cadre of professional social workers, who integrate the values-framework of social equality, social inclusion, human rights and social justice; and as agents of social change and social entrepreneurship, endeavor to achieve behavioral change, social transformation and social development. The Department is known for its local community development initiatives in villages and international collaboration with Nepal, Bhutan, Bangladesh, Sri Lanka and China.

**Dharwad Institute of Mental Health and Neurosciences** is an autonomous organization of Govt. of Karnataka, established in the year 1845. It is a 375 bed hospital spread in 20 acres. It has well-furnished and equipped library, laboratory, rehabilitation centre, free legal aid cell and family counselling centre. Academic wing for Psychiatric Social Work is already established. Mental health professionals and faculties are sufficiently recruited. Psychiatrists (13), Clinical Psychologists (6), Psychiatric Social Workers (7), and Psychiatric Nurses (52), are efficiently extending mental health services to the most excluded segment of society in the whole of North-Karnataka.

Now, therefore, Central University of Karnataka and Dharwad Institute of Mental Health and Neuroscience agree to enter the following MOU:

**1. ACADEMIC:**

- 1.1. Program : M.Phil. in Psychiatric Social Work, Central University of Karnataka
- 1.2. Mode : Regular mode
- 1.3. Duration : Two Academic Years
- 1.4. Intake : 8 (Eight) Per Year/ as per CUK rules
- 1.5. Eligibility : MSW with Specialization in Medical and Psychiatric Social Work/ Post-Graduation in Social Work with Papers studied on Mental Health/ Psychiatric Disorders/ Psychotherapies, Psychiatric Social Work or related paper/s.
- 1.6. Admission : Through the Entrance test conducted by the Department of Social Work, Central University of Karnataka. After admission process, the details of the candidates admitted to the Course will be informed to the Director, DIMHANS.
- 1.7. Medium : English
- 1.8. Mode : Annual Pattern (Part-I, First Year and Part-II, Second year)
- 1.9. Board of Studies: Board of Studies is constituted by the Dept. of Social Work, CUK. However, two faculties may be invited to represent the DIMHANS - one faculty from the Dept. of Psychiatric Social Work, and another faculty from the Department of Psychiatry/ Clinical Psychology/Allied health and mental health sciences.
- 1.10. Curriculum : As recommended by the Board of Studies, Dept. of Social Work and approved by the Academic Council, CUK. The curriculum shall be on par with the national standard of NIMHANS or any national or international mental health institution.

**2. ACADEMIC:**

**2.1. Academic Calendar:** Academic planning of the two year course and for each batch, time table, clinical placement, assignments, presentations, case conferences and reports will be planned by the Dept. of Social Work, CUK, in consultation with the Dept. of Psychiatric Social Work, DIMHANS. Joint Seminars/workshops may be planned depending on the need.

**2.2. Teaching Plan:** Teaching of theory papers will be conducted at CUK and DIMHANS. In the beginning of the Academic year theory papers will be completed at CUK, and then placed for clinical training at DIMHANS, Dept. of Psychiatric Social Work. Simultaneously, theory part will also be conducted.

**2.3. Clinical Placement:** Intensive and rigorous clinical training through sound theory, therapeutic practice, Rehabilitation Social Work and Research-base will be carried at DIMHANS. Candidates will be allotted to OPD and various Neuro-Psychiatric Services, FCC, Departments, Rehabilitation Centres, Community Mental Health Projects or any agency as per the scheduled plan, issued by the Department of Psychiatric Social Work, and/ Neuro-Psychiatry/Clinical Psychology, DIMHANS, as per the discussion held with the Dept. of Social Work, CUK. candidates shall be allotted to Unit Heads for all the clinical purposes; which will be monitored and supervised by the Dept. of Psychiatric Social Work, DIMHANS.

**2.4. Clinical Supervision and routine clinical placement:** Dept. of Psychiatric Social Work, DIMHANS, frame time table and clinical placement. Teaching faculties of the Dept. of Psychiatric Social Work and the Psychiatric Social Workers act as Clinical supervisor/s of each M.Phil. candidate; then keep and maintain attendance, assignments, reports, academic progression report, and any individual level work assignment/s and assessment records. Under special circumstances, Psychiatrists and Clinical Psychologists may also work as Clinical Supervisor/Co-Supervisor for each M.Phil. candidate.

**2.5. Mental Health Services:** *The M.Phil. candidates, as mental health professionals, are required to extend mental health services to patients, families and communities, both inside and outside DIMHANS, as per the need.*

**2.6. Student Academic Records:** Department of Psychiatric Social Work, DIMHANS, as part of clinical placement shall maintain candidates' attendance records, therapeutic reports, case reports, intervention reports, working papers, field assignments or any practical reports/records. All the reports/records shall be handed over to the Dept. of Social Work, CUK. However, the candidates are required to submit and present all their assignments, case records, case reports (diagnostic, assessment and therapeutic and rehabilitation reports) in duplicate to the Dept. of Psychiatric Social Work, DIMHANS, and the Dept. of Social Work, CUK. However, confidentiality shall be maintained at each level.

**2.7. Student assessment:** Periodic assessment shall be carried as per the curriculum. Joint plan of assessment shall be planned by the Dept. of Social Work, CUK, and the Dept. of Psychiatric Social Work, DIMHANS.

**2.8. DISSERTATION:** As per the UGC and CUK Guidelines, each M.Phil. candidate will be allotted a Supervisor and/ Co-Supervisor. Supervisor will be from the Dept. of Social Work, and/Dept. of Psychology, CUK. Co-Supervisor will be Psychiatrist and Psychiatric Social Worker, and/Clinical Psychologist from DIMHANS, who will be recognized as Co-Supervisor/s, by CUK, as per the UGC Guidelines. Professor/s and Associate Professor/s shall be Co-Supervisor by virtue of their designation. However, Asst. Professor/s shall be Co-Supervisor provided they meet the requirements of the CUK guidelines. Dissertation topics will be decided in joint consultation, considering the research needs of DIMHANS, emerging mental health research areas and depending upon the field/community needs and priorities. Approval from the Ethics Committee will be obtained for dissertation.

**2.9. Examination:** Theory examination will be conducted at CUK. Practical examination shall be planned as per the curriculum and guidelines of CUK at DIMHANS. The place and schedule of examination require prior approval from the Controller of Examinations, CUK. Practical examinations will be conducted at DIMHANS. Head Dept. of Psychiatric Social Work be a main examiner, and faculty of the Dept. of Social Work, CUK will be a member of the panel. However,

Psychiatrist or Clinical Psychologist may also be invited as a member for the practical examination.

**2.10. Evaluation:** Head, Dept. of Social Work, CUK, will be the Chairman of Board of Examinations. All the answer scripts and examination records of the M.Phil. candidates will be under the control of the Head. Faculty of the Dept. of Psychiatric Social Work, and/ Psychiatry/Clinical Psychology, DIMHANS, may be recognized as evaluator/s to assess the examination records and answer scripts, with prior permission from the Controller of Examinations, CUK. Passing grade will be as per the regulation of CUK.

**3. Student support from DIMHANS:**

- 3.1. Arrangements will be made to provide hostel facility (both food and accommodation). The candidates will make payment towards the same.
- 3.2. Access to Library & E- Resources will be provided. Identity card with joint title and logo (CUK & DIMHANS) will be issued to the candidates for book transaction.
- 3.3. ICT, Internet, cubicle and furniture support will be extended to all the candidates.
- 3.4. Two Classrooms will be provided for the M.Phil. Course, as per requirement.

**4. PUBLICATION:**

All publications of the M.Phil. candidates will be jointly shared by the Candidate, Supervisor, Co-Supervisor (Psychiatrists, Clinical Psychologists) and Psychiatric Social Worker/s of CUK and DIMHANS.

**5. FINANCIAL:**

- 5.1. There is no clinical financial burden of the MPhil Course on the part of the CUK. Clinical fees will be directly borne by the MPhil candidates. The Clinical fee for the First M.Phil. Batch will be Rs. 1,000/- per month for each candidate; for the Second M.Phil. Batch Rs. 1,500/- per month for each candidate; for next batches Rs. 2000/- per month for each candidate. M.Phil. candidates shall directly pay the clinical fee to the DIMHANS, receipts of the fee will be submitted to the Dept. of Psychiatric Social Work, DIMHANS and the Dept. of Social Work, CUK. M.Phil. candidates shall preserve the clinical fee receipts till the end of the M.Phil. Course.
- 5.2. DIMAHNS will provide Boarding and Lodging facilities to M.Phil. candidates on payment by the MPhil candidate/s. Advance or monthly payment/s will be directly collected from each M.Phil. Candidate by the DIMHANS.
- 5.3. Any damage to the property of DIMAHANS, caused by the candidate/s, knowingly or unknowingly, the candidate/s will restore/compensate the damage.

**6. MONITORING:**

- 6.1. A Committee consisting of Head and a faculty from the Dept. of Social Work, CUK, and Director/Head and a faculty from the Dept. of Psychiatric Social Work, Psychiatry and Clinical Psychology, shall hold periodic review meetings either at DIMHANS or CUK, to monitor the effective implementation of the M.Phil. Program.
- 6.2. The review report shall be submitted to the Registrar, CUK and the Director, DIMHANS, to facilitate the effective implementation of the program.

**8. Duration of MOU:**



Collectively the CUK and the SELCO are hereinafter referred as "the Parties"

Whereas, the company is engaged in the business of designing, assembling, selling and servicing of solar energy products with the main objective of providing energy access to underserved population. As part of CSR activity the SELECO has launched/proposing to start Village Care Program in various regions including Kalyan Karnataka region.

WHEREAS, The CUK through the Department of Social Work has collaborated with the villages with an objective to promote village development in the area of promoting education, health, gender, entrepreneurship, skill development, livelihood programs; empower Grama Panchayat system, undertake sustainable social/community development initiatives etc. Department of Social Work shall be the nodal Department to implement the Gram Swarja - Rural Community Development Project for Sustainable Community Development Interventions; and shall work in collaboration with Department of Business Studies, School of Engineering and other Departments of CUK in the planning, execution, monitoring and

Both the organizations are collectively referred as Responsible Parties in the rest of this MOU.

Now, therefore, it is hereby agreed between the parties as follows:

1. SCOPE AND OBJECTIVES OF THE MOU

The parties shall work in a framework of mutual synergy and understanding for achieving the following objectives -

1.1 Village/Community Engagement: Organizing Gram Sabha with villagers for primary discussion to understand their actual felt needs. It enables reaching different sections and segments of the villages (youth, farmers, women, children, elderly, PWD, migrants, poor etc.), govt. agencies and CBOs to form stakeholder-groups for social justice, equity, empowerment, development, behavior change, social and economic change and social transformation.

1.2 Base-line Survey: Baseline survey of the collaborated villages has to be conducted jointly by CUK and SELCO Company and with the collaboration of the villages, to understand the needs, priorities and issues of the villages; and also envision social map of the villages as a blue-print for desired action.


1.3 Identifying the local needs: Based on the survey, a proper report has to be prepared to understand the actual local needs of the collaborated villages and should be analyzed for further process of implementation.

1.4 Preparing the Roadmap/Action plan: Preparation of development roadmap based on the survey data and identified needs of the villages with appropriate solutions.

1.5 Budget Preparation: Based on the roadmap, estimation of expenditure and sources of income is to be prepared.

**1.6 Funds:** As far as possible an effort shall be made in identifying the Govt. agencies, CSR funding agencies, charity, philanthropy etc. for sponsoring the implementation of programs. If need arises both or either parties will also fund the project according to the agreement reached as and when need arises. The funding support depends on the provisions available with both the parties.

**1.7 Organising Seminars, Workshops and Trainings:** The Parties will explore the opportunities to organize the seminars, workshops and trainings jointly or in collaboration with other agencies, institutions etc., (wherever necessary) for the stakeholders and target groups of the villages.

**1.8 Monitoring:** The progress of the program is to be periodically monitored by the committee formed by the both parties. [May be Quarterly and a format to be prepared]

**1.9 Modification if any:** Based on the periodical monitoring and revive of the progress of the said program it can be modified the said program with mutual consent of both the parties and in consultation with the stakeholders of the villages.

**1.10 Execution of the Program:** Execution for the program will be done by the CUK and SELCO based on the need-assessment report, research report, monitoring and evaluation report and impact report.

**1.11 Publications:** Any publications resulting from the above joint efforts will be published in both the parties name.

**1.12 AMENDMENTS:** If there is a need, the parties may agree to amend the terms and conditions of this MOU, so as to reflect such a need with the consent of both parties.

## 2. Amendments, Duration and Termination

2.1 Any amendments to this MOU can only be made in writing and after consultation and mutual consent of both the parties. Such amendments, once approved by both the parties, will become part of this MOU and are incorporated by reference.

2.2 The effective date of this MOU shall be the date on which the both the parties hereto execute their original of this MOU;

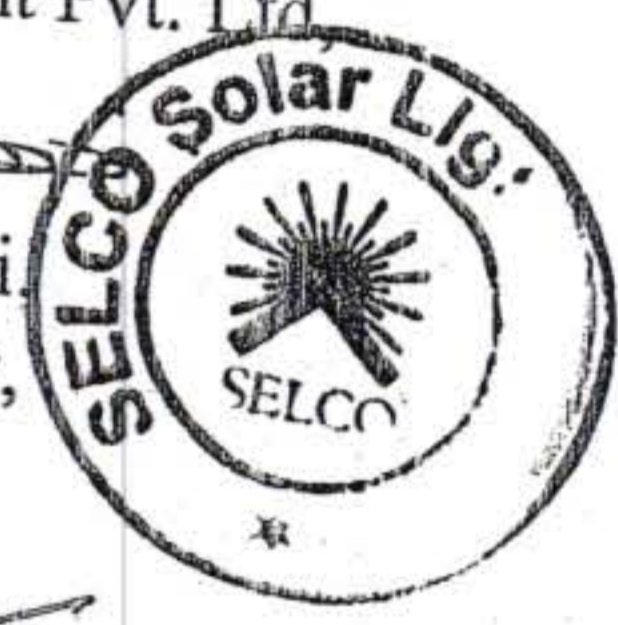



### Term and Scope of Services

iv) Fourth Instalment of 20% of the total amount will be paid to the Service Provider on submission of the data entry, compilation and analysis of the data and submission of the first draft report.

v) Fifth & Final Instalment of 20% of the total amount will be paid to the Service Provider on submission of the final report as per the deliverables quoted in point 7 of the Terms of Reference.

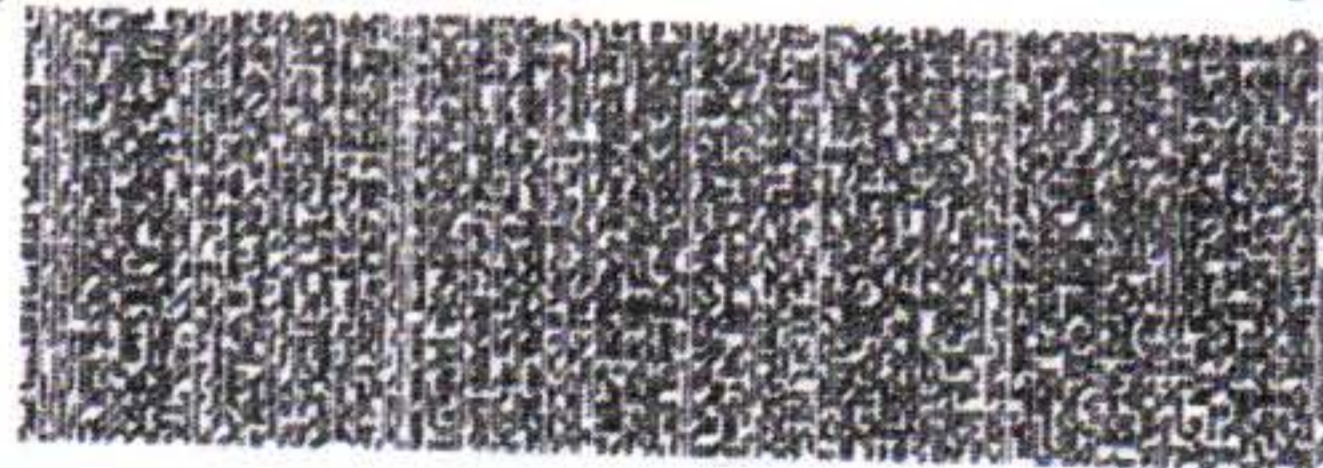
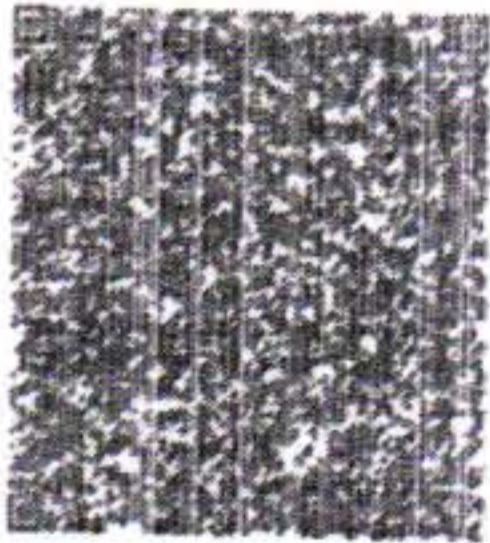

## MEMORANDUM OF UNDERSTANDING

WHEREAS the **M/S BRUNDHAVANA FOUNDATION KALABURAGI**, with trust registration No: GLB-4-00042-2020-21, a registered Society under the Registration of Societies Act 1860 (Hereinafter referred to as the Foundation) is desirous of carrying out programs in the areas of urban waste and Hospital waste management and have set up a Common Healthcare Urban Waste And Bio-Medical Waste Management Solution (CHUBS) which has been authorized by Karnataka State Pollution Control Board, **Government of Karnataka**.

AND WHERE AS, **CENTRAL UNIVERSITY OF KARNATAKA KADAGANCHI, KALABURGI**, is individual Health Care Establishment (Hereinafter referred to as HCE's) acting through **MEDICAL OFFICER**, with 4 numbers of beds has agreed to avail the services of the Common Healthcare Urban Waste and Bio-Medical Waste Management Solution (CHUBS) set up by the above said Foundation.

AND WHEREAS the Foundation would be making necessary arrangement to manage the plant, machineries and dispose the Waste as envisaged under the relevant rules for handling and management of Bio Medical Waste generated by the hospitals in general.

Both the parties agree to work together in the field of Hospital Waste Management as under:

### TERMS OF REFERENCE:

Responsibilities of the Occupier of Healthcare Establishment (HCE)

1. To obtain authorization from the Karnataka State Pollution Control Board (KSPCB) with service afforded actual number of beds in their HCE's.
2. To segregate waste at the point of generation in accordance with Schedule I & II of the Bio-Medical Waste Management Rules, 2016 and designated color coded bags; bar coded which are to be procured from M/s Brundhavana Foundation only. On site segregation and storage should be according to standards prescribed.
3. To establish secured waste collection site for storage within the HCE's before handing over to the waste collector of CHUBS. Large bins or trolleys from storage area to the transport vehicle would have to be arranged by the HCE's. The waste storage room should be easily accessible for lifting the waste.

4. To ensure that the waste is handled without causing health hazards to human health and the Environment
5. To furnish annual reports regarding generation, collection, storage, transportation and disposal of Bio-Medical Wastes in the prescribed format to the prescribed authority.
6. To designate a Nodal Officer responsible for interacting with CHUBS and KSPCB.
7. To disinfect sharp materials and mutilate them or at least hand them over in a puncture proof and secure container for mutilation and sterilization at the site. Puncture proof equipment's to be purchased from CHUBS only.
8. To use appropriate bags and bins for segregation, collection and storage of Bio-Medical Waste using prescribed color codes, along with barcodes before handing over to the CHUBS representatives for treatment. These bags would have to be provided by the CHUBS only at the cost of HCE's.
9. Regular payment of service charges will be the responsibility of the HCE's. The HCE's would have to make the arrangements for the payment of the service charges along with the applicable taxes to the authorized person of the CHUBS.
10. On time payment of service charges will be the responsibility of the HCE's. The HCE's will have to make the arrangements for the payments of the service charge to the authorized Person of CHUBS in the form of DD only drawn in Favor of M/s BRUNDHAVANA FOUNDATION, KALABURAGI -02.

Services to be provided by the CHUBS:

1. To schedule the collection timings and mode in consultation with the HCE's but within a reasonable range of time.
2. The CHUBS representatives would arrange to collect the segregated Bio-Medical Waste from specific locations meant for storage of Bio-Medical Waste of each of the HCE's with whom this MOU is being signed.
3. The CHUBS will be responsible for the safe transport of the Bio Medical Waste from the HCE's to the common facility in accordance with the Bio Medical Waste Management (Bio Medical Waste Management) Rules, 2016.
4. Appropriate treatment and disposal of different categories of waste would be carried out by CHUBS in accordance with the Bio Medical Waste Management Rules, 2016 and time to time amendments.

5. Monitoring and ensuring complete disinfection/sterilization of the wastes in accordance with the Bio Medical Waste Management Rules will be carried out in collaboration with the **Karnataka State Pollution Control Board (KSPCB)** at Kalaburagi.
6. A liquid effluent treatment plant to treat the liquid wastes emanating from the HCE Could be established and operated in accordance with the Environment Protection Act (EPA) 1986. Brundhavana foundation would help in designing and constructing of the ETP suitable for the HCE at the sole cost of HCE only.
7. The collected waste material would be checked periodically for segregation, labeling etc., and suggestions would be given for improvement to the HCE's, which the HCE's must implement.
8. Appropriate timely training will be provided by the CHUBS to the HCE personnel for segregation, transport to the facility vehicle, storage etc. as and when sought by the HCE administration. The HCE shall cooperate and accommodate the suggestions given during training and incorporate them in their practices in the spirit of co-operation and goodwill and to comply with Bio Medical Waste Management Rules 2016.
9. Waste audit and quantification will be carried out at the individual HCEs by CHUBS from time to time, which will be submitted to the Hospital Administrator/Medical Superintendent of the HCEs with a Copy to the Karnataka State Pollution Control Board. The HCE should co-operate and facilitate the same as in enumerating the beds.
10. Consent for operation and authorization by Karnataka State Pollution Control Board for the facility will be obtained by the CHUBS and regularly renewed.
11. Certificate for the proper transport vehicle will be procured by the CHUBS.
12. The CHUBS will collect the Bio Medical Waste from the HCE's having valid authorization of Karnataka State Pollution Control Board.

**JOINT PROCEDURE ORDER:**

CHUBS will collect, transport, store, treat and dispose the different wastes in accordance with the Bio-Medical Waste Management Rules 2016 and will avoid becoming liable for improper treatment or disposal. The HCE's giving their wastes to the CHUBS if willing to check then need to take prior written approval and then will have the right to enter and inspect the site to ensure the above

**Emergency Contingency Plan:**

In case of failure by CHUBS authorized person to the collect waste for more than 48 hours from the designated time of collection from the HCE, representative of CHUBS and the KSPCB will be informed by the HCE. CHUBS will collect the waste from the HCEs 6 days in the week (excluding Sundays).

Collection of waste may not be undertaken on major holidays declared by Government. CHUBS will intimate the HCEs about the non collection days every quarter. CHUBS will not undertake collection of waste in the case of strike, lockout, closer or riots in the city and any other such conditions beyond its control.

In case there is disruption of services either in the collection, transportation, storage such as breakdown at the treatment and disposal site, alternative temporary arrangements will be made for disposable of the waste.


This MOU is made to obtain authorization from Karnataka State Pollution Control Board and the Bio Medical Waste will be collected from HCE's only upon submission of the valid authorization.

**Mode of Payment:**

A payment of **Rs.6.00 per bed per day** will be paid in advance by the bedded HCEs every quarter. The payment will be collected every quarter and will have to be given by the HCE's to the authorized person from CHUBS in the first week of the month of that quarter for which the waste collection is going on. HCE's will have to make arrangements for the timely payment of the service charge which includes transportation cost along with the applicable taxes to the authorized person of CHUBS only in the form of DD drawn in Favor of **M/S Brundhavana foundation, KALABURAGI.**

In case of constant delay in payment or non-payment by the HCE for more than 15 days of the deadline stipulated in the above Para, the CHUBS will stop the Collection of Bio Medical Waste and MOU will be cancelled and the HCE name will be informed to the Karnataka State Pollution Control Board to take further action against the HCE under Bio Medical Waste Management Rules, 2016.

The above said rate is applicable to the HCEs till next rate revision. After rate revision, New rates will be applicable to all Government and private bedded, non-bedded HCEs of entire Kalaburagi.

**Whereas**

Central University of Karnataka (CUK) was established by an Act of the Parliament (No. 3 of 2009) at Kalaburagi, Karnataka. It is one of the 16 Central Universities newly established by the Government of India during the XI Plan Period to address the concerns of equity and access, by providing quality higher education for the people living in educationally under developed districts of the state. The CUK, with its territorial jurisdiction all over Karnataka started its academic and research activities, since its establishment in 2009.

The University campus is spread over 654 acres, near Kadaganchi, a village in the district of Kalaburagi, Karnataka. The main objective of this growing University is to integrate teaching, learning, training, research, innovation, and skill development with an aspiration to excel in under graduate, post graduate and doctoral studies. objectives of both parties to highlight the cultural heritage of Tamil Nadu as revealed through archaeological studies and investigations under this MoU. These are defined as follows:

### Academic and Research Activities and Public Outreach

- Planning and handling of academic and research activities, organizing seminars, workshops and conferences, museum development and enhancement, and teaching, in the field of archaeology and geology and any other field with their theory and methodology that would enhance the existing knowledge, in areas to be mutually agreed upon prior to commencement of any specific project.
- Internship and training programs for the students in the field of archaeology and museums.
- Utilization of Laboratories, infrastructures and human resource of the respective institutions with mutual agreement.
- Public outreach and education in the above fields and allied sciences through exhibitions and reinterpretation centers and Museums.
- Pedagogical activities in the above fields.

### OBJECTIVES

1. To conduct archaeological explorations in Karnataka and Tamil Nadu, including recording and documentation of sites and prepare detailed exploration reports.
2. To conduct archaeological excavations in the select archaeological sites followed by permit from ASI.
3. To collect, document, analyse and evaluate the archaeological samples of the archaeological sites.
4. To collect samples for dating archaeological findings/ sites, and samples shall be provided to test in the concerned laboratories. Radiometric, OSL, Dendrochronology, Fission Track or any other relative and absolute dating methods to place the archaeological sites in proper cultural context.
5. To study geo-archaeology of the study area for mapping landscapes, land use and resource catchments with the use of geo-spatial methods.
6. To analyse and interpret the physical and digital data to reconstruct the cultural past
7. To disseminate the knowledge gained with professional journals and with the civic bodies

### DURATION

The duration of this MoU is for 3 (three) years, i.e. from date of signing of MoU and can be extended for a similar/and or an agreed period thereafter through mutual agreement.

## NATURE OF FINANCIAL ASSISTANCE

The quantum of and type of assistance and source of funds needed for execution of each item specified or project will be identified and agreed upon by both parties prior to commencement of any work.

## MONITORING AND EVALUATION

TNIAM-TNSDA and CUK will agree to hold meetings at regular intervals to discuss progress made and resolve issues if any.

The MoU shall not be altered, varied or modified nor any of its provision waived otherwise than in writing signed by both the parties hereto and affixed to this MoU as an amendment to original.

## TERMINATION

Either party may terminate the agreement after giving 6 months' notice, and endeavor to settle through mutual discussions any issue arising from same during that period.

The parties will discuss and agree on the terms of such dissolution prior to commencing work on any project to avoid any financial or similar distress to the party concerned.

On the aspects where the Articles of this MoU are silent or for cases relating to deviation from these articles, efforts would be made to resolve the issues through mutual dialogues and consultations between TNIAM-TNSDA and CUK.

If such resolution is not possible then the unresolved disputes and differences shall be referred to the Sole Arbitrator jointly appointed by TNIAM-TNSDA and CUK, whose decision will be final and binding on both the parties.

## FORCE MAJEURE

Neither party shall be held responsible for non-fulfillment of their respective obligations under this Agreement due to the exigency of one or more of the force majeure events such as but not limited to Acts of God, war, flood, earthquakes, strike, lockouts, epidemics, civil commotion, etc., provided on the occurrence and cessation of any such events, the party affected thereby shall give a notice in writing to the other party within one month of such occurrence or cessation. If the force majeure conditions continue beyond six months, the parties shall then mutually decide the future course of action.

**Publications in print, online, conference/workshop presentations:** Both TNIAM-TNSDA and CUK will mutually agree to the sequence of authorship of any publications based on international protocols prior to submitting any research material for consideration of publication in print/online or any other format.

Both TNIAM-TNSDA and CUK will mutually agree to the sequence of authorship and nature and structure of presentations to be made on the research results that may need to be presented at conferences, workshops, seminars or meetings be they academic or for public interest/outreach.

Presentations and material to be reported will be jointly finalized by both TNIAM-TNSDA and CUK before selecting the venue for presentation and person/persons who will present the same.

**Confidentiality:** Each party shall not make any public announcement or statement or publish or release any information in relation to any proposed activity or proposed collaboration without the prior written approval of both parties. Each party shall keep confidential any information that it receives from the other party which is marked confidential or which a party notifies the other party is confidential.

**Storage:** Archaeological antiquities obtained during the course of the project, and other samples (fossils, sediments, etc.) will finally be housed at the TNIAM-TNSDA and CUK, and will be their

responsibility. These, however, will be made available to either party for conducting analysis, research, writing reports, etc., at any time during and after the project by mutual agreement.

## COLLABORATORS

Both TNIAM-INSDA and CUK will mutually agree to the choice of other collaborating agencies (Institutes, scholars, or other like) prior to involving them in the project.

## GENERAL CLAUSE

Each project agreed under this MoU by a separate written communication shall be read as part and parcel of this MoU and terms and conditions agreed there under shall be read together without any deviation / departure from this MoU.

## MISCELLANEOUS CLAUSE

The headings and sub-headings are inserted for convenience only and shall not affect the construction of this MoU.

All activities conducted under this Memorandum of Understanding will be in accordance with all applicable rules and regulations of the Union and State Government.

## SUMMARY

Neither party shall subcontract nor assign this MoU in whole or in part or make without the prior written consent of the other party. Any purported subcontract or assignment is null and void.

This MoU represents the entire agreement between the parties with respect to the subject matter hereof and will be independent of and have no effect upon any other contracts.

The purpose of this MoU is to express the intentions of the parties, specifically for the research and public outreach activities.

The terms of co-operation for other specific activities contemplated under this MoU shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of that activity. 





ii) **Joint research projects:** For the development of industries and Entrepreneurship Development in the HKR both CUK and K-LAMP will undertake joint research project. The funding and other operational modalities will be discussed need based at an appropriate time.

iii) **Capacity Building:**

a) **Students:** CUK will avail the support of K-LAMP in building students' capabilities through internships. For this, K-LAMP will provide an opportunity to the CUK students to do internship in its member organizations.

b) **Research Opportunities for Faculty:** K-LAMP will provide an opportunity in its member organizations to do research on the issues faced by the organization to find practical solutions to the problems. **iii) Capacity Building:**

a) **Students:** CUK will avail the support of KKCCI in building students' capabilities through internships. For this, KKCCI will provide an opportunity to the CUK students to do internship in its member organizations.


b) **Research Opportunities for Faculty:** KKCCI will provide an opportunity in its member organizations to do research on the issues faced by the organization to find practical solutions to the problems. 

- iii) Collection, Study, Research and Publication of Books, Inscriptions, Manuscripts, Monuments of Vachanakaras.
- iv) Publication of literature on Vachanakaras available in other languages and the translation of the same from other major languages into Kannada and vice versa.
- v) Organizing National and International Seminars, Conferences, Workshops and Symposiums on the works and life of Vachanakaras and publishing the proceedings of the same.
- vi) Reviewing vachana literature and works on the life of Vachanakaras for the purpose of editing the existing literature without diluting its essence.
- vii) Undertaking research on the philosophy of Vachanakaras and publishing the same.
- viii) Creation of Musical composition on the Vachanas and making audios and videos and digitalizing the same.
- ix) Identifying and studying the places where the Vachanakaras were borne, lived advocated their philosophy and wrote vachanas.

international levels and the use of such infrastructure facilities will be subject to availability and on payment of minimum user charges/free.






