- 11. (1) The Vice-Chancellor shall be appointed by the Visitor in such manner as may be prescribed by the Statutes.
 - (2) The Vice-Chancellor shall be the principal executive and academic officer of the University and shall exercise general supervision and control over the affairs of the University and give effect to the decision of all authorities of the University.



First meeting of the NEP-2020 Implementation Committee was convened at the committee room, Admin building on 25th November 2021 at 3.30pm.

Prof. Channaveer RM, Member Secretary of the NEP-2020 Committee welcomed the Chairperson and members of the committee. The chairperson, Prof. MV Alagwadi presided over the meeting.

In the meeting, the members deliberated, discussed and resolved the following -

- Prof. M.V. Alagwadi briefed the members that the implementation of NEP in CUK was discussed and deliberated thoroughly in a Two-day NEP implementation Workshop held on 4th and 5th Oct 2021 and the road map to design the framework of program structure or Curriculum framework for four years UG, PG and integrated Programs on the lines of NEP.
- In each department, concerned Head/Coordinator will be responsible to convene the faculty meetings
 to deliberate, discuss and carry out SWOT analysis of the department for deciding the framework of
 Program Structure (Curriculum framework) of Integrated/four year UG and/or two-year PG Programs
 which are currently run in their respective departments.
- 3. The Program structure/Curriculum framework will show various courses namely Languages, Foundation, Ability Enhancement, Skill Development, Core (Major/Minor), Electives etc., taught in each semesters. Multidisciplinary components, Skill development, Industry linkages, Employability and tie-up with Sector Skills Council wherever feasible shall be part of curriculum framework.
- 4. The Curriculum Framework for existing programs of UG, PG and Integrated programs shall be submitted to the Academic Section with a copy to the member secretary Prof RM Channaveer on or before 31st Dec 2021 for further needful action.
- 5. The respective Heads/Coordinator shall ensure that the approval of Board of Studies (BOS) is obtained by 15th Jan 2022 for the proposed Curriculum Framework/Program Structure of the programs being offered in their respective departments and also approval for syllabus/curriculum for the courses to be taught in Fist year (First and Second Semester).
- 6. The number of times entry and exit and total duration for completion of the program is decided at University level for integrated/four year UG program by the appropriate bodies.
 - 7. The respective Heads/Coordinators may invite experts if need be with the prior approval of the Competent authority. The Dean of the school is required to supervise and coordinate the implementation of NEP in their respective schools.
 - 8. NEP framework prepared by the Govt. of Karnataka and Delhi University for higher education programs will be shared as additional inputs.

- (iv) The details of awareness programme about NEP, 2020 conducted by volunteers of NCC/NSS/NYKS/UBA need to be collected. It was brought to notice that as on date around 2 crore stakeholders have been made aware about NEP, 2020. [Action: ICC/Policy Bureau]
